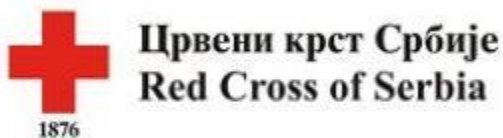

Položaj Crvenog krsta Srbije

Crveni krst Srbije vrši javna ovlašćenja utvrđena zakonom i obavlja druge poslove od javnog interesa, u skladu sa ratifikovanim međunarodnim ugovorom, zakonom i drugim propisima i opštim aktima i pri njihovom vršenju, odnosno obavljanju ima položaj organizacije koja pomaže nadležnim državnim organima u humanitarnoj oblasti. U obavljanju poslova iz svoje nadležnosti, odnosno delatnosti Crveni krst Srbije uživa pomoć nadležnih državnih organa, organa teritorijalne autonomije i jedinica lokalne samouprave...

Ciljevi i zadaci

Crveni krst Srbije ima za cilj da olakšava ljudsku patnju, sa zadatkom da pruža pomoć ugroženim licima u slučaju ratnih sukoba, prirodnih, ekoloških ili drugih nesreća radi spasavanja ugroženih života i zdravlja ljudi i obezbeđenja poštovanja humanitarnog prava.

THE RED CROSS OF SERBIA – 138 years of serving endangered people

THE RED CROSS OF SERBIA HAS BEEN RECOGNIZED BY THE EMERGENCY LAW AS AN IMPORTANT PROTECTION AND RESCUE FACTOR IN SERBIA especially based upon its position, as well as objectives and tasks.

The Red Cross of Serbia Law ("Official Gazette of the Republic of Serbia" ref. 107/2005 DETERMINES:

The position of the Red Cross of Serbia

The Red Cross of Serbia carries out public authorized activities stipulated by the Law and performs any other operations of public interest, in accordance with the ratified international contract, the Law and other rules and general regulations and during its carrying out and performing, it has got the position of an organization helping the relevant Governmental authorities in the humanitarian branch.

While carrying out the activities within its authorization, i.e. performance, the Red Cross of Serbia shall be assisted by the relevant Governmental and Territorial Autonomy authorities and the Local Self-Government units.

Objectives and tasks

The Red Cross of Serbia has got the objective of facilitating human suffering, with the task of helping the endangered persons in case of war disputes, natural, environment or any other accidents, in order to save the endangered lives and health of people and guarantee the humanitarian right implementation.
